### **PAST REPRESENTATION**

- \$43.1 million verdict in Summerlin v. R.J. Reynolds Tobacco Company.
- Plaintiff v. Warren Pumps, et al.: Represented a career pipefitter at a New Hampshire paper mill who developed mesothelioma as a result of exposure to asbestos from pumps, valves, steam traps and other equipment at the paper mill. The case was prepared for trial in Massachusetts state court, and settled on the eve of trial for several million dollars.
- Plaintiff v. Northrop Grumman, et al.: Represented a former Navy aircraft mechanic who developed mesothelioma as a result of exposure to asbestos from aircraft brakes and component parts. Case settled shortly after the trial started for significant seven-figure sum.
- Seang v. Armstrong Ambulance: Two ambulance occupants sued after the ambulance they were being transported in slammed into a disabled car on an interstate highway, causing serious personal injuries. Case tried to a jury in Suffolk Superior Court, Boston. \$6.4 million verdict, over \$8 million with pre-judgement interest.
- Plaintiff v. Borg Warner, et al.: A paper mill worker developed mesothelioma as a result of exposure to asbestos in a paper mill that was manufacturing asbestos-containing friction paper.
- Plaintiff v. Boeing, et al.: Career USAF aircraft mechanic developed mesothelioma as a result of exposure to asbestos from aircraft component parts. Case settled the day of trial for significant seven-figure sum.
- Plaintiff v. Crane Co, et al.: Represented a former Navy machinist-mate who developed mesothelioma as a result of exposure to asbestos onboard Navy ships. Case settled just prior to trial for significant seven-figure sum.
